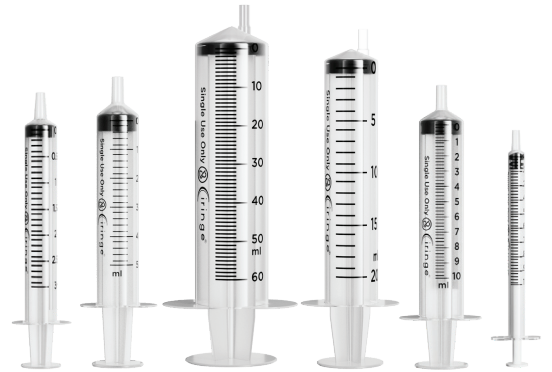


PRODUCT DESCRIPTION

- CIRINGE® is a brand name for Hypodermic Syringe.
- It is a medical device used to inject fluid into or withdraw fluid from the body.
- The syringe consisting of a plunger rod, barrel and stoppers/gasket.
- CIRINGE® is a disposable syringe which sterile-packed individually using Ethylene Oxide (EO) gas according to ISO 11135.
- The products are packaged with blister packs with a definitive usage life-span marked on the packs. Blister packs provide protective barrier that helps safeguard products from external factors.
- It is made of plastic and synthetic components that had been tested for free from toxicity and fit for intended use.
- The plunger rod, barrel and tip shield made from high clarity Polypropylene ensuring easy identification and monitoring.
- The non-slip plunger base does not leave the barrel during withdraw.
- Stoppers/gasket is made from latex free Isoprene rubber with medical grade silicone for lubrication to get a smooth draw.
- CIRINGE® product ranges are also intended to be used either alone or in combination with needle.
- Manufactured according to Standard ISO 7886.
- Registered with Medical Device Authority of Malaysia under Act 737.
